The Finance Committee reported:- 104 (1918)

We recommend that the sum of \$1539.79 be transferred from the General Expense Fund and placed to the credit of the Park Department General Fund, to be used for the improvement of the Field House and Golf Course in Griffith Park.

The Health and Sanitation Committee reported:- 2105 (1918)

In the matter of Communication No. 2105 from Supervisor Woodley with reference to the application of the Union Ice Company on Santa Monica Boulevard, to connect their plant with the City sewer, your Committee will state that the application was denied and filed by this Council on the 7th day of June, this year, in communication No. 1118. We have since, however, ascertained that the amount of discharge into the City sewer by said Ice Company would be approximately 2000 gallons per day, and the City Engineer stated that this discharge would in no way affect the efficiency of the sewer. In view of this and the fact that the said Ice Company is a customer of the City in the purchase of power to operate its plant, your Committee recommends that the action heretofore taken by this Council on June 7, 1918, denying application of the Union Ice Company for permission to connect with the City sewer be rescinded, and in lieu thereof that the request be granted and the Board of Public Works instructed to issue a revokable permit for said sewer connection, upon the filing and approval by said Board of plans and specifications for said sewer connection. All costs and fees to be paid by the Petitioner.

Mr. Conaway moved, seconded by Mr. True, that the report as read be adopted. Which motion was adopted by the following vote:- Ayes, Messrs. Cleaveland, Conaway, Conrad, Criswell, Olsen, Reeves, True and President Farmer (8). No, Mr. Mallard (1).

The Clerk reported that on November 6, 1918, the Board of Public Works had filed its assessment for the opening and extending of Normandie Avenue from Rosewood Avenue to Oakwood Avenue, as contemplated by Ordinance No. 37315, New Series.
